DOCKET TERMS AND CONDITIONS

APPLICABILITY: The provisions set out and referred hereinunder in this docket shall apply to transportation through any mode and shall not be restricted one mode of transport only.

D E F I N I T I O N S :

(a) GATEL - 'Gati-Kerala Express Private Limited'

(b) Delivery - means delivery of shipment or package or information about the arrival of shipment at its destination.

(c) Partner - means man and woman Shipper, Receiver or their authorized representatives.

(d) NOC - Means No Commercial Sales as defined by the Seller.

(e) GATEL - Means to Commercial Sales as defined by the Seller.

(f) INTRAM - means and includes original, Demurrage/Over time charges, etc.

(g) GATEL Miles - refers to a coupon issued by GATEL, the parties, which is not to be exchanged with cash in lieu of cost of freight and / or demurrage.

2. GATEL is entitled to use any mode and route for transportation.

3. The docket is a contract between GATEL and partner.

4. Declaration :-

i) The declarations enunciated by the parties on the basis of declaration made by the parties, GATEL shall not be responsible for any incomplete/inaccurate/wrongful declarations as above in various bills & Bills of Lading.

b) GATEL shall not assume any personal liability, unless the 'Declaration Form' available with the operating unit concerned is duly signed up above affixing my signature and handed to the authorized person.

c) In the event of any discrepancy found by GATEL in weighing documents in shape and the actual weight of the shipment, the differential charges shall be collected from my partner.

d) The docket is issued specifically on the basis of declaration made by the parties, GATEL shall not be responsible for any incomplete/inaccurate/wrongful declarations as above in various bills & Bills of Lading.

e) GATEL shall not be liable for any damage caused due to improper and defective packaging of goods.

f) The liability of GATEL in the handling of dangerous articles or materials shall be limited to the extent of freight only.

g) GATEL shall not be liable for any loss or damage caused due to the event of Freight Only.
