- g. The envelope containing the postal ballot form is received after the last date prescribed;
- h. The postal ballot form, signed in a representative capacity, is not accompanied by a certified copy of the relevant specific authority;
- i. It is received from a Member who is in arrears of payment of calls;
- j. It is defaced or mutilated in such a way that its identity as a genuine form cannot be established;
- k. Member has made any amendment to the Resolution or imposed any condition while exercising his vote.
